1. Vendor agrees to be a vendor at the Clinton County Fair the evenings of Monday July 14 through Saturday July 19, 2025.
2. Vendors are afforded 10'x10' or 10'x20' spaces in the Exhibition Building on the grounds of the Clinton County Fair, Carlyle, IL. Payments are due upon turning in application to secure your spot. The fee for the week or any portion thereof is as follows.

3. All stands will be held responsible for the cleanliness of the stand and the immediate surrounding area. All debris must be placed in containers to be hauled away by 8am each morning. This is a State requirement and failure to comply can cause the closing of the stand by the State Inspector.
4. Deliveries to stands must be completed by or before 5pm each day.
5. Vendor assumes all responsibility for security, damage, liability of quality, etc. No site security is provided. Vendor understands the building is open Monday-Friday night from 5:00-9pm (11pm optional) Saturday 2pm-9pm (11pm optional). Vendors are responsible for having an attendant on hand if they wish to have their stand manned during the building's open hours; otherwise the stand is unattended.
6. Stand workers will keep their vehicles in the regular parking area and will never drive and/or park by the stand without first obtaining special permission from the parking superintendent.
7. Parking is \$5.00/day per vehicle unless a parking permit is obtained from the fair office. Weekly parking passes are \$14.
8. A completed and signed lease must be returned by July 1, 2025 and be signed by both the vendor and a fair official to be valid. **Early bird special if you get your application in before April 1st, 2025 you will receive a free ¼ page ad in the Clinton County Fair Book**
